- 2. My name is Tim Colenback. I am Assistant Dean for Student Services and I will be the host for this session. This session will cover some of the important information regarding course planning for 16 Month schedule and 20 Month schedule students.

# 4. 16/20 Month Program Requirements

- 18 credit hours of foundation courses are required for students unless they are exempted from course(s). Many MSW students will be exempted from some foundation courses. Exemptions are provided to students who have covered the course content of a foundation course in the past six years in courses where they received "B" or better grades.
- Each student in the 16/20 Month program is required to complete 912 hours of field work which translates into 15 credit hours including two credits of foundation fieldwork (SW 515), a one credit hour foundation field seminar (SW 531). Additionally, each 16/20 Month student is required to complete 12 credit hours of advanced fieldwork (SW 691). Most 20 Month students will enroll in foundation fieldwork and the foundation field seminar in Fall Term 2016. Most 20 Month students will enroll in four credits of Advanced Field during Winter Term 2017, Fall Term 2017 and Winter Term 2018. Most 16 Month students will enroll in foundation fieldwork and the foundation field seminar in Winter Term 2017. Most 16 Month students will enroll in eight credit hours of advanced field in Spring/Summer Term 2017 and complete fieldwork by enrolling in four credit hours of advanced fieldwork in Fall Term 2017. Some 16/20 Month students will complete their fieldwork in a different sequence and will need to complete an Out-of-Sequence petition.

- Each student is required to complete six credit hours of advanced coursework in their Practice Method. Please consult your Course Planning Worksheet to identify which courses will meet your Practice Method requirement.
- Each student is required to complete nine credit hours of advanced coursework in their Practice Area. Please consult your Course Planning Worksheet to identify which courses will meet your Practice Area requirement.
- Each student is required to complete the advanced evaluation course: SW 683.
- Each student is required to complete nine credit hours of electives.
- The total number of credit hours required to complete the 16/20 Month MSW degree is 60.

# 5. 16/20 Month students are required to complete the following foundation courses/field work unless exempted:

- SW 531 (One Credit/Unit)

#### 9. **SW 521 For Macro Concentrators**

Management, Social Policy & Evaluation & Community Org. student select from the following

- o SW 521 010
- o SW 521 011

Macro students are not required to complete SW 511, but are required to complete 512.

#### 10. Exemptions

Exemptions for foundation coursework are offered to many students:

- Exemptions are based on coursework completed in past six years with "B" or better grades.
- Transcripts are automatically reviewed through the Office of Student Services (OSS) for exemptions.
- Exemptions do not reduce credit hour requirements, but do allow for students to replace the foundation course with an elective course
- Exemption decisions are e-mailed to your umich.edu e-mail address prior to your registration appointment time.
- Exemption decisions may be appealed. If you believe you should be eligible for an exemption from a foundation course and you do not receive an exemption, please contact OSS at 734/936-0961.
- Although most students do accept exemptions due to the rich elective course offerings in the MSW program, you do not have to accept an exemption even if it is provided.
- No exemptions are given for SW 504, SW 511 (IP) or SW 512 (CO, MHS, SPE)

#### 11. Substitutions

- Students can replace a foundation course requirement or an advanced course requirement with the permission of the Associate Dean (in the summer prior to enrollment) or with the permission of their advisor and the Associate Dean (following the beginning of the program).
- Substitution for a foundation course would typically require completing an advanced course in the same part of the curriculum. (For example, a student would typically need to substitute an advanced Social Welfare Policy and Services course for SW 530 and an advanced macro methods course [Management of Human Services, Social Policy and Evaluation or Community Organization] for the SW 560 course.)
- Students sometimes substitute a required course with mini courses or even a course outside of the School of Social Work.

# 12. Practice Method and Practice Area Options

#### Practice Methods:

- Community Organization
- Interpersonal Practice
- Management of Human Services
- Social Policy and Evaluation

#### **Practice Areas:**

- Aging in Families and Society
- Children and Youth in Families and Society
- Community and Social Systems
- Health
- Mental Health

Each student selects a Practice Method concentration and a Practice Area in which to apply their method at the time of application. If you would like to change one of your selections or have questions, please contact OSS at 734/936-0961.

# 13. Course Planning Worksheets

- All students should become very familiar with the course planning worksheet for their schedule and concentration combination.
- Note that the worksheets set out a schedule for a student with no exemptions.

#### 14. Course Planning with an Exemption

- Most 16 Month students replace exempted courses typically completed in the fall term with an advanced required or elective course where pre-requisites have been met.
- Most 20 Month students complete either 521 (macro students) or 560 (IP students) if they receive an exemption for a course typically enrolled in during the first fall term
- Occasionally it is necessary to complete an advanced course simultaneously with a pre-requisite course (e.g., SW 521 and SW 623, SW 624, SW 625 or SW 628)

# 15. Advanced Course Requirements

# **Practice Methods Requirements**

- Two Courses are Required
- Interpersonal Practice
  - Two of: 623, 624, 625, 628
- Community Organization
  - Two of 650, 651, 652, 654, 657, 658, 674
  - It is recommended CO students enroll in 650, 651 or 652 as their first advanced CO course.

#### 16. Practice Methods Requirements (continued)

- Management of Human Services
  - Two of 651, 660, 661, 662, 663, 664, 665
- Social Policy and Evaluation
  - 673 and one of: 670,671, 674, 685

# 17. Practice Area Requirements

- Three Courses
  - Aging in Families and Society: 616, 644, 694
  - Children and Youth in Families and Society: 633 and 696 and either 601 or 605
  - Community and Social Systems: 647 and 697 and either 611 or 620

# 18. Practice Area Requirements (continued)

- Health: 613 and 634 and 699
- Mental Health: 636 and 698 and either 606 or 612

# 19. Additional Advanced Course Requirements

- Evaluation -All students must complete an evaluation course: SW 683
- Field Instruction –All students must complete 12 credit hours (684 clock hours) of Advanced Field Instruction (SW 691)
- Electives –All students must complete nine credit hours of electives (more if exempted from any foundation courses)

# 20. Additional Advanced Course Requirements (continued)

- Students enrolled in a Special Scholarship program should refer to the specific course planning worksheet for their program to identify curricular requirements.
- Students pursuing a specialization/certification should refer to the website for specific advanced course requirements.
- Students pursuing a dual degree should work closely with their advisors throughout their enrollment to determine foundation/advanced course requirements.

# 21. Elective credit options

There are many options for utilizing elective credits while in the MSW program. It is important for students to think about these options. Options for utilizing electives include:

- Minor Method. Students minoring must enroll in two advanced method courses in their minor method. This will utilize six elective credit hours. Additionally, students selecting a minor must complete three credits of their advanced fieldwork in their minor method.
- <u>Specialization or Certification.</u> Several specializations and certifications are offered by the SSW including child welfare, school social work, global social work, and aging. Specializations and certifications typically require the use of nine credit hours of elective credit.
- Special Programs. Students enrolled in special programs (Child Welfare Scholarship Program, Community-Based Initiative in Detroit, Detroit Clinical Scholars Program, Geriatric Scholarship Program, Global Activities Scholarship Program, Integrative Health Scholars Program, Jewish

- Community Leadership Program, National Community Scholars Program) utilize electives to meet special program requirements.
- More courses related to your practice method or practice area. Some students elect to complete more than the minimum required credits in their practice area and/or method.
- <u>Courses unrelated to your practice method or practice area.</u> Other students broaden their experience by enrolling in courses in Practice Areas and/or Methods outside of their concentration.
- Mini courses (One credit courses, SW 790 and SW 799). Mini courses are very popular. The SW 790 sections are typically one credit hour interpersonal practice courses and SW 799 sections are typically one credit hour courses related to Management of Human Services, Community Organization or Social Policy and Evaluation. Mini courses typically meet for 15 total hours spread over two to five sessions. CO students are strongly encouraged to enroll in a CO focused mini course in fall and winter terms.
- <u>Electives in the SSW: Three credit hour courses (usually 700 level, but include some 600 level courses)</u>. The School offers several 700 level courses and some 600 level courses that are free standing electives which do not meet concentration or specialization requirements in the program.
- <u>Doctoral Courses (800 level courses).</u> Some doctoral courses are open to MSW students with permission of the instructor.
- <u>Independent Studies</u>. The School offers students the opportunity to receive credits for independent work via the special studies option. Students set up a learning agreement with a faculty member to complete independent studies. Students may enroll in a maximum of eight credits of independent studies in a given term or a total of 16 credits while in the program.
- <u>Courses outside SSW</u>. Students may enroll in courses in other schools, colleges or departments in the University of Michigan. Three sites provide information on relevant courses external to the School:

- Additional Field Instruction. Students may add up to six credit hours above the minimum
  advanced field requirement to cover elective credit hours. Each student is required to complete
  684 hours of advanced fieldwork (12 credit hours). For each 57 hours of additional fieldwork
  completed above the 684 hours, a student can receive one credit toward their elective credit
  requirements.

# 22. SW 631: Web-based Integrative Learning & ePortfolio Development

- SW 631 is a blended mini-course with f2f (face-to-face) and online components. Open to all MSW students, this course is intentionally designed with opportunities to engage in integrative (connective) learning, feedback/forward, professional identity exploration, and creation of a unique and meaningful online portfolio.
- This is a 1-credit course which can be used to fulfill elective credit

# 23. Changing Program Selections

Occasionally students want to change a curriculum choice. Prior to the beginning of the program students may request changes by sending an e-mail to <a href="mailto:ssw.oss@umich.edu">ssw.oss@umich.edu</a>.
Students may request a change of:

- Practice Method
- Practice Area
- Add/Delete Practice Method Minor
- Curriculum Schedule (16 month, 20 month, Advanced Standing)

Please provide a rationale for your request in the e-mail you send.

# 24. Registration Tips

- Registration is through: wolverineaccess.umich.edu
- Be sure to park courses in your backpack via <u>wolverineaccess.umich.edu</u> prior to your registration appointment time.
- When searching for field (SW 515 or SW 691) be sure to include "independent studies."

#### 25. Registration Tips (continued)

- Fall Term 2016 may be the best term to access a course outside of the School of Social Work for 16 Month students. Why? You are typically not in field during the first fall term.
- If you decide to pursue this option, and you an interpersonal practice concentrator, you should delay enrollment in SW 560 until Winter Term 2017 (if you do not have any exemptions).
- If you decide to pursue this option and you are a Community Organization, Management of Human Services, or Social Policy and Evaluation concentrator, you should delay enrollment into SW 521 until Winter Term (if you have no exemptions).

# 26. Registration Tips (continued)

• Be sure to include the units (usually 2) when registering for field work (SW 515).

Utilize the Petition to Enter a Closed Course (<u>ssw.umich.edu/secure\_forms/closed\_course.html</u>)
if you would like to gain entry to a closed course (we do not use the "waitlist" function on
wolverineaccess.umich.edu).

- Thoroughly read the information including the MSW courses listings and "outside classes" on the site: <a href="mailto:ssw.umich.edu/courses">ssw.umich.edu/courses</a>
- <u>Class Descriptions</u> this link has information on all courses approved by the SSW faculty. Some courses may not be available in a given term.
- Winter 2016 Class Schedule read through this link to understand which courses are offered in a typical Winter Term. The schedule for Winter 2017 will be similar, but not available until Fall 2016.
- <u>Fall 2016 Class Schedule</u> this is the schedule for Fall 2016. Some of the information available here is not included in the course listings on wolverineaccess.umich.edu
- <u>Spring/Summer 2016 Class Schedule</u> read through this link to understand which courses are offered in a typical Spring/Summer Term. The schedule for Spring/Summer 2017 will be similar, but not available until Winter Term 2017.
