Foundation Courses

- SW 500
- SW 502
- SW 521
- SW 522

Foundation Fieldwork

- SW 515 (two credits or units)
- SW 531 (one credit or unit)

Exemptions

- Based on coursework completed in past six years with "B" or better grades
- Transcripts automatically reviewed through OSS for exemptions
- Exemptions do not reduce credit hour requirements, but do allow for students to replace the foundation course with an elective course
- Exemption decisions are e-mailed to your umich.edu e-mail address prior to your registration appointment time
- Decision may be appealed
- You do not have to accept an exemption

Substitutions

- Students can replace a foundation course requirement or an advanced course requirement with the permission of the Associate Dean (in the summer prior to enrollment) or with the permission of their advisor and the Associate Dean (following the beginning of the program).
- Substitution for a foundation course would typically require completing an advanced course in the same part of the Curriculum. (For example, a student would typically need to substitute an advanced Human Behavior in the Social Environment course for SW 502 and an advanced macro methods course (Management of Human Services, Social Policy and Evaluation or Community Organization) for the SW 560 course.)
- Students sometimes substitute a required course with mini courses or even a course outside of the School of Social Work.

Course Planning Worksheets

- Course Planning Worksheets are available at <u>ssw.umich.edu/studentguide</u>
- All students should become very familiar with the course planning worksheet for their schedule and concentration combination.
- Note that the worksheets set out a schedule for a student with no exemptions.
- Most 20 Month students replace exempted courses typically completed in the fall term by completing both SW521 and SW560 (typically 20 Month students enroll in one of these courses in Winter Term of their first year). Some students with multiple exemptions may enroll in advanced required or elective coursework where pre-requisites have been met.
- Occasionally it is necessary to complete an advanced course simultaneously with a pre-requisite course (e.g., SW 521 and SW 623, SW 624, SW 625 or SW 628).

Practice Methods Requirements

- Two Courses are Required
- Interpersonal Practice
 - Two of: 623, 624, 625, 628
- Community Organization
 - Two of 650, 651, 652, 654, 657, 658, 674
 - It is recommended CO students enroll in 650, 651 or 652 as their first advanced CO course.

Practice Methods Requirements (continued)

- Two Courses are Required
- Management of Human Services
 - Two of 651, 660, 661, 662, 663, 664, 665
- Social Policy and Evaluation
 - 673 and one of: 670,671, 674, 685

Practice Area Requirements

- Three Courses
- Aging in Families and Society
 - 616, 644, 694
- Children and Youth in Families and Society
 - 633 and 696 and either 601 or 605
- Community and Social Systems
 - 647 and 697 and either 611 or 620

Practice Area Requirements (continued)

- Three Courses
- Health
 - 613 and 634 and 699
- Mental Health
 - 636 and 698 and either 606 or 612

Additional Requirements:

- Evaluation -All students must complete an evaluation course: SW 683
- Field Instruction -All students must complete 12 credit hours of Advanced Field Instruction (SW 691)
- Electives -All students must complete 9 credit hours of electives (more if exempted from any foundation courses)

Special Option for CO Students

- Special pilot option for 16 or 20 month Community Organization concentrators
- Enroll in SW 560 Section 002 (Introduction to Community Organization, Management and Policy/Evaluation Practice) and SW 513 Section 005 (Community Organization Skills Laboratory)
- Replace SW 502 requirement with SW 513 Section 005
- Petition for entry into SW 560 Section 002 to gain entry into both SW 560 Section 002 and SW 513 Section 005
- Will provide enhanced preparation for practice in community organization

Special Option for IP/CY Students

- Special pilot option for 16 or 20 month students selecting the Interpersonal Practice method and the Children and Youth in Families in Society Practice Area
- Enroll in SW 521 Section 002 (Introduction to Interpersonal practice) and SW 513 Section 006 (Children and Youth Skills Laboratory)
- Replace SW 500 requirement with SW 513 Section 006
- Petition for entry into SW 521 Section 002 to gain entry into both SW 521 Section 002 and SW 513 Section 006
- Will provide enhanced preparation for practice in utilizing interpersonal practice skills with children, youth and families.

Special Pilot Option for IP/MH

- Special pilot option for 16 or 20 month Interpersonal Practice concentrators selecting a Practice Area of Mental Health
- Enroll in SW 521 Section 010 or 011 (introduction to Interpersonal Practice) and SW 513 Section 003 or 004 (Interpersonal Practice Skills Laboratory)
- Replace SW 612 requirement with SW 513 Section 003 or 004
- Petition for entry into SW 521 Section 010 or Section 011 to gain entry into both SW 521 Section 010 or 011 and SW 513 Section 003 or 004
- Will provide enhanced preparation for practice in mental health settings
- Pilot option is <u>required</u> for Clinical Scholars and Integrated Health Scholars -- Scholars should petition for SW 521 section 010
- 20 Month students selecting this option and without exemptions should delay enrolling in SW 530 until their second fall term of enrollment and should delay enrolling in SW 636 until their second winter term of enrollment

SW 504 Diversity and Social Justice in Social Work

• SW 504

A foundation course designed to increase students awareness, knowledge, and understanding of issues related to diversity, human rights, social and economic justice. The topics of this course include developing a framework for 1) engaging diversity and differences in social work practice and 2) advancing human rights and social and economic justice.

• SW 504 will substitute for SW 502

Submit a Substitution Form to the SSW Registrar's Office to use SW 504 in place of SW 502.
