

Affidavit of Financial Support for International Students

If you will need an F-1 or J-1 visa, the University of Michigan is required by U.S. government regulations to obtain documentation proving that international students have adequate financial resources to provide for their expenses, including dependents, for the duration of their program. If you are currently in the U.S. on an F or J visa, you must also send a copy of your recent I-20 or DS-2019 along with a copy of your passport, I-94 card and visa if you are offered admission.

You are required to submit an affidavit of financial support with your application for admission. If you are offered admission, you are required to provide certification of the availability of a minimum of \$192,849 (U.S. dollars) to cover your expenses for the two-year four-term MSW program or \$125,576 (U.S. dollars) if you are eligible for a three-term MSW program. Additional certification will be required if you plan to bring dependents with you. Funds may come from a variety of resources, including personal/family, government, or sponsoring organization. Keep copies of all financial documents to present to the U.S. Consulate when applying for a visa.

REQUIREMENTS FOR DOCUMENTATION OF FUNDS

Complete both pages of the Affidavit of Financial Support form and provide documentation as required.

- Official and original dated bank statement(s) showing current balance or official letter from bank stating that funds are available, including the amount available, and that the funds "may be withdrawn at any time without penalty" must be provided. (Do not submit long statements that include transaction history.)
- All accounts must be easily accessible and liquid assets.
- Electronic documents are acceptable, but must clearly be from an original document.
- All documents must be in English. Otherwise, an official English translation must accompany the original.
- All supporting documentation must be dated within three months of I-20 or DS-2019 processing.
- Letters of sponsorship must include the exact dollar amount of support (in US dollars) and dates of sponsorship.

The following may not be used as documentation of funds:

- Statements verifying employment and salary
- Insurance premiums and policies
- Property or personal assets (automobiles, land, buildings, jewelry, etc.)
- Non-liquid assets or stocks, bonds, equities, retirement accounts
- Income tax returns
- Attestations stating only that a sponsor can meet the expenses

Note: All credentials submitted for issuing the immigration document become the property of the University of Michigan and will not be returned in original or copy form.

Immigration documents will be sent to admitted applicants after they have paid their enrollment deposit confirming their plans to enroll and have provided required documentation. Immigration documentation processing usually begins in Feb/March.
