What is "Field"?

Field education (field placement, field practicum, field experience or simply "field") is the hands-on, real-world training portion of the MSW curriculum.

- What? Hands-on learning & practice
- Where? Community agency or organization

Field is the opportunity for you to take what you learn in the classroom and apply and practice these concepts and skills in a real world learning environment.



Why is field important?

To learn and to serve

Students are expected to:

- Integrate life experiences, classroom education, previous work/volunteer experiences and apply them to field experience
- Reflect on your strengths and areas for growth
- Become an experienced lifelong learner: learning to know what you don't know
- Serve individuals, families and communities and strive for social justice




Where will my field placement be?


- "Local" options in Michigan and Northern Ohio, most in Ann Arbor and Detroit
- Most students travel more than 30 minutes, many 60 minutes
- National and international field placement options





How do I get there?

- Indicate on your field placement application if you do not have a car
- Placement options are limited if you do not have personal transportation
- SSW travel stipend if you travel outside a 30 mile radius
- Carpooling with others students
- Ann Arbor Transportation Authority (ride for free)

What is expected of you in your field placement?

Entering your field placement

Agencies and Field Instructors understand that you're a student who is there to learn. You are not expected to come in with any specific social work skills or knowledge, as this is what you will be learning in the program.

However, as a professional graduate social work student you are expected to have skill and attributes in the following areas:

- Communication
- Intellectual and Cognitive Ability
- Emotional and Behavioral Readiness



What is expected of you in your field placement?

Those with work significant experience in social work settings

If you are someone entering the program who has worked in a social work setting (other than your undergraduate field placement), please indicate this on your field placement application in the comments section.

We can often find you field placements that will challenge you by encouraging you to explore a different topic, setting or to learn more advanced skills.





What is expected of you?

Best approach to field

- Field is a class
- Embrace all you do as learning
- Be open, flexible and patient
- Be willing to seek out opportunities
- Take risks and make mistakes
- Expect responsibilities to progress every term
- Engage in self-reflection and be a critical thinker



- Pace of advancement will differ
- Be prepared to face challenges
- Embrace discomfort rather than avoid it
- Manage uncertainty
- You may question the agency's approaches and policies
- Want, seek and use feedback



How is field different than jobs and internships?

Field placement, internships and jobs

- Opportunity to practice in the real world environments, similar to other professions. Remember field is a class.
- Developing social work competencies, your professional identity and behavior.
- You will complete a learning contract ("educational agreement") where you will identify assignments that will guide your learning experience
- Your presence will be a benefit to the clients and communities you are serving, but the main purpose is your learning
- A few agencies do provide stipends but not all

Steps to Apply for Your Field Placement:

- 1. Prepare to Apply
- 2. Compose and Submit Your Field Application
- 3. Interview
- 4. Prepare to Start





How to prepare to apply

- Reflect on your learning goals and current skills
- Reflect on what qualities you're looking for in a field supervisor (field instructor)
- Reflect on what you'd like your first job to be once you leave the MSW program and what basic skills you need to be qualified

Remember: Be flexible and open-minded; every field placement is a learning experience






Compose your goal statement and resume

Goal statement: 1-2 page written statement that we share with potential your field placements to give them an idea of your knowledge, skills and interests

Follow the goal statement guidelines to compose



• The Office of Career Services (CSO) website has guidelines and examples

BOTH: Email your drafts to the CSO Writing Center before you submit (optional); must be submitted to CSO (ssw-cso@umich.ed) at least 2 weeks prior to field application deadline.





Review the available field placements and submit your field placement application

- Search available field placements
- Rank your top 6 choices
- Fill out the remainder of the field placement application
- Upload your goal statement and resume


Rank your top 6 choices: 1. Blue's Community Center

- Reach out to our office
 - If we already work with them
 - If we don't already work with them





What happens after you apply

Confirmation email

Email to introduce your initial field faculty placer

Field Faculty will review your materials

Your materials will be sent to a field agency (usually your first choice)





What happens after you apply

Interview process

- One agency at a time
- In-person, phone or virtual


Approval Process
